



RELEASE OF LIABILITY

I, the undersigned, hereby release Intensity Basketball and all affiliated with Intensity Basketball from any claims for injury, illness or property damage that I sustain and/or cause during my participation, or sustained by my daughter/son/minor in my care participating in this event, program or other which is any way related.

I accept and assume all risk inherent in this activity or that may have been caused by the negligence of Releasees. Releasees are defined as partners, sponsors, officers, members, agents, employees and any other organization, entities, and individuals who are serving Intensity Basketball including all volunteers assisting with programs, events or other activities.

I understand that by participating in practices and games that the possibility of physical injury exists including but not limited to: physical injuries such as sprains, twists, cuts, scrapes, or even death: surface hazards or equipment failures. If my child is injured and requires medical care, including ambulance transport, I consent to such care. I accept responsibility for any and all medical expenses incurred whether or not covered by insurance.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasee from any and all claims, demands, or causes of action that are any way connected with participation in this activity, or my use of equipment or facilities arising from negligence.

PHOTO RELEASE

FEES AND REFUNDS

PLAYING TIME

I understand that the coaches may physically and mentally challenge my child during practices and games. I understand that while the coaches will try to play every child on the team, they will determine playing time based on physical and mental readiness. I understand that my inability to get my child to practice on time could affect their readiness to perform in games and therefore playing time.

I understand that the main goal of Intensity Basketball is to teach my child the fundamentals of basketball and prepare her to play at a higher level.
